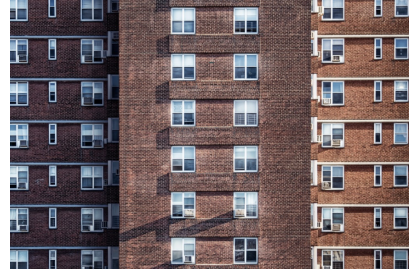

## Transportation-Related Funding Opportunities

**"Free" Money - Do You Qualify?**



Earlier this year, CROCOG was selected to receive a grant through the Federal Highway Administration (FHWA) Electric Vehicle Reliability and Accessibility Accelerator Program (EVC-RAA). This funding is available to repair electric vehicle charging stations that are identified on [this list](#), which includes potentially eligible projects in the following municipalities:

## CT DOT Active Transportation Microgrant Program

**Application Deadline: Rolling Basis until funds are exhausted - half the funds are available.**

The Connecticut Department of Transportation (CTDOT) has created a new Active Transportation Microgrant Program to work in conjunction with the Safe Routes to School Program. The purpose of the program is to provide eligible applicants with **up to \$5,000** for non-infrastructure resources that advance safe, accessible, sustainable, and equitable walking, biking, and rolling.

Eligible applicants include schools, school districts, municipalities, and 501(c)(3) nonprofit organizations. Eligible items include bicycle helmets; bicycle locks; bicycle fleets; safety vests; bicycle maintenance training and materials; League Cycling instructors training; and programs, events, and materials for bicycle and pedestrian safety education.

**Up to \$500,000 is available for this program**, which will be administered and distributed by COGs until utilized. Applicants may apply for up to two grants per 12-month period. View the [Program Guidelines](#).

## FHWA Low Carbon Transportation Materials Program (LCTM)

Application Deadline: **November 25, 2024**

The Federal Highway Administration (FHWA) has \$800M available to non-State entities for the Low Carbon Transportation Materials Program (LCTM). This program seeks to reimburse or provide incentives for the use of construction materials and products that have substantially lower levels of embodied greenhouse



gas emissions in eligible transportation projects.

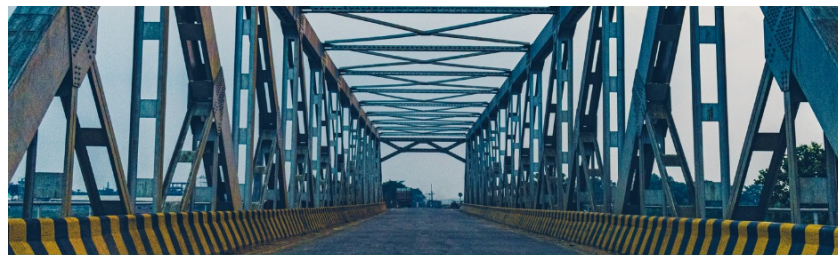

## U.S. DOT Financing Programs - TIFIA, RRIF

In addition to the numerous discretionary and formula funding programs, U.S. DOT offers **flexible loan programs** like [TIFIA](#) and [RRIF](#) to finance **large transportation projects**. Funding for **Transit-oriented Development (TOD)** projects is now also available for eligible areas. The [TOD Eligibility Map for TIFIA and RRIF](#) identifies the following CRCOG municipalities as eligible: **Berlin, Rocky Hill, Glastonbury, Hartford, Windsor, Windsor Locks, and Enfield.**

**Important to note:** the map does not identify all potentially eligible TOD areas in our region. Just because your municipality is not listed above or highlighted on the map does not mean you cannot pursue this loan program.



### USDOT BRIDGE INVESTMENT PROGRAM

#### PLANNING GRANTS AND BRIDGE PROJECT GRANTS

- \* **Program Purpose:** To reduce the overall number of existing bridges (or culverts) on the National Bridge Inventory that are in poor condition, or in fair condition at risk of falling into poor condition. Applications are being accepted on a rolling basis with the following upcoming deadlines:
  - **Large Bridge** (eligible costs over \$100M) are due **August 1, 2024**;
  - **Planning Applications** are due **October 1, 2024**; and
  - **Bridge Projects** (eligible costs of \$100M or less) are due **November 1, 2024**
- \* **Minimum Award Amounts – Bridge Project:** \$2.5M; **Planning Grants:** No minimum.
- \* **Maximum Award Amount:** up to 80%, except up to 90% for off-system bridges

## U.S. DOT Bridge Investment Program

**Large Bridge and Planning Grant Application Deadlines: Rolling-basis**  
**Bridge Project Application Deadline: November 1, 2024**

The **Federal Highway Administration (FHWA) Bridge Investment Program** is an excellent opportunity for municipalities to improve existing bridges or culverts that are listed on the **National Bridge Inventory**. The goal of this program is to improve bridge condition and the safety, efficiency, and reliability of the movement of people and freight over existing bridges.

There are two funding categories in this program: **(1) Planning**; and **(2) Bridge Project grants** (with total eligible costs not greater than \$100M).

- **Planning Grants:** Up to \$80M is available for FYs 2023 through 2026. There is no maximum or minimum grant award amount; however, grant awards must not exceed 80% of total eligible project costs (a 20% non-Federal cost share is required).
- **Bridge Project Grants:** Up to \$9.62 B is available for FYs 2023 through 2026 for projects with total eligible costs of **\$100M or less**. Minimum grant awards of \$2.5 M, and maximum grant awards of 80% of total eligible project costs (a 20% non-Federal cost share is required).
- **Large Bridge Project Grants:** Funding available for projects with total eligible costs greater than \$100M.

The [Notice of Funding Opportunity \(NOFO\) for Planning and Bridge Project Grants](#) establishes a “rolling application” process. The schedule, requirements, and selection process for applications is provided for the remaining available amounts of BIP funding.

## Environment and Energy-Related Funding Opportunities

### CT DEEP Open Space and Watershed Land Acquisition (OSWA) Grant Program

Application Deadline: **December 2, 2024**



The Connecticut Department of Energy and Environmental Protection (CT DEEP) is providing financial assistance to municipalities, non-profit land conservation organizations (e.g., land trusts) to **acquire land for open space**, and to water companies to **acquire land to protect, preserve and secure state water supply**. The amount of funding provided is dependent on several project specifics.

This is an excellent opportunity to **conserve and preserve land for open space and natural resources** while making it **publicly accessible for non-intensive development**, such as for trails/pathways for pedestrians, motorized wheelchairs or nonmotorized vehicles.

## **DOE- Energy Improvements in Rural or Remote Areas (ERA)**



Pre-Application Concept Paper (mandatory): **February 27, 2025**  
Application Deadline: **August 28, 2025**

The Department of Energy (DOE) Office of Clean Energy Demonstrations (OCED) is offering grants of **\$2M or more to communities of 10,000 people or fewer**. The **Energy Improvements in Rural or Remote Areas (ERA) Program** seeks to **improve energy infrastructure in rural areas through grid upgrades and implementation of renewable generation**. The award has a ceiling of \$50M.

## **USDA – Solid Waste Management Grant Program**

The U.S. Department of Agriculture (USDA) **Solid Waste Management (SWM) Grant Program** is providing \$4M in grants for technical assistance and/or training programs to improve the planning and management of solid waste sites. The program seeks to reduce or eliminate pollution of water resources in rural areas and improve planning and management of solid waste sites in rural areas. There is a ceiling of \$1M per grant.

## CT DEEP Climate Resilience Fund

**Another round of funding is coming soon!**

The Connecticut Department of Energy and Environmental



Protection (CT DEEP) is preparing for a second, expanded round of its [Climate Resilience Fund Program \(DCRF\)](#). DCRF seeks to make Connecticut more resilient to the impacts of climate change and extreme weather through the following potential solutions:

- stormwater parks,
- resilience hubs that serve as cooling and warming centers,
- microgrids and clean backup power and storage, and
- establishing stormwater authorities.

CTDEEP has issued a [Request for Information](#) to receive feedback on its proposed structure for a newly expanded Climate Resilience Fund, including a new Climate Resiliency Revolving Loan Fund.

## CT DEEP Materials Management Infrastructure Grant Program (MMI)

Application Deadline: **Rolling Basis until  
December 6, 2024**

MMI makes **\$15M** available to one or more municipalities; Councils of Government (COGs); Regional Waste Authorities; or Resource Recovery Agencies (RRAs) for capital projects.

**Regional applications are preferred.**

This program also prioritizes projects that will enhance diversion of materials from the waste stream, increase recycling, and reduce waste.

**U.S. EPA Solid Waste  
Infrastructure for Recycling  
(SWIFR) Program**

Application Deadline: **December 20, 2024**

The U.S. Environmental Protection Agency is accepting applications for the [Solid Waste Infrastructure for Recycling Grant Program \(SWIFR\)](#) to strengthen America's recycling infrastructure and advance the circular economy to promote a more sustainable future. **\$58M** is available to communities for projects that will improve collection, transport, systems, and processes related to post-use materials that can be recovered, reused, recycled, repaired, refurbished, or composted. Awards are expected to range from **\$500,000 to \$5M** each.



The [Recycling Education and Outreach \(REO\) Grant Program](#) is also open, but is designed to award **\$39M to one coalition** to develop a national consumer wasted food reduction campaign, focused on expanding the market for sales of compost, and increasing education and outreach to households on composting. As this is a national campaign, CRCOG will not apply for the REO grant, but will continue to follow its development.

**U.S. EPA Reducing Lead in  
Drinking Water Grant Program**

Application Deadline: **December 30, 2024**

The U.S. Environmental Protection Agency

(EPA) is accepting applications for the **Reducing Lead in Drinking Water Grant Program**. **\$35M** is available for applications that one of the following National Priority Areas:



1. Reduce lead in drinking water in disadvantaged communities through full lead service line replacements or treatment improvements, such as corrosion control practices; **or**
2. Reduce children's exposure to lead in schools and childcare facilities in disadvantaged communities through removal and/or replacement of lead-containing drinking water fixtures, fountains, outlets, and plumbing materials.

## **U.S. EPA Environmental & Climate Justice Community Change Grant Program**



**Application Deadline: Rolling Basis until November 21, 2024**

The EPA is making **\$2B available** to fund community-driven projects to address climate challenges and reduce pollution through the **Community Change Grants**. The program will enable communities and their partners\* to overcome longstanding environmental challenges and implement meaningful solutions to meet community needs now and in the future.

There are two funding tracks:

1. **Community-Driven Investments for Change** will fund about 150 large, transformational community-driven investment grants of **\$10 million - \$20 million** to meaningfully improve the environmental, climate, and resilience conditions affecting disadvantaged communities. A review of the [EPA IRA Disadvantaged Communities Map](#) reveals that **19 CROG Member Municipalities** contain Census Tracts that meet EPA's definition of disadvantaged community: **Berlin, Bloomfield, Columbia, East Hartford, Enfield, Hartford, Manchester, Mansfield, New Britain, Newington, Plainville, Rocky Hill, Simsbury, Southington, Vernon, West Hartford, Wethersfield, Windsor, and Windsor Locks**.
2. **Meaningful Engagement for Equitable Governance** will fund about 20 meaningful engagement grants of **\$1M - \$3M**.

Grants may be used for:

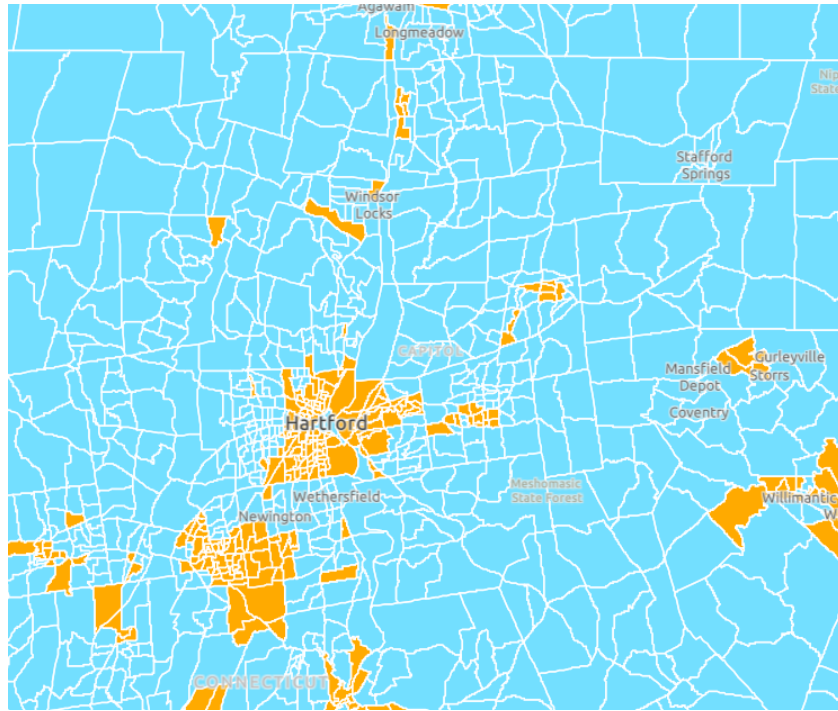
- Air and other pollution monitoring, prevention, and remediation, and investments that help reduce greenhouse gas emissions<sup>1</sup> and other air pollutants;
- Mitigating climate and health risks from urban heat islands, extreme heat, wood heater emissions, and wildfire events;
- Climate resiliency and adaptation;
- Reducing indoor toxics and indoor air pollution;
- Facilitating engagement of disadvantaged communities in state and federal

## Brownfields Redevelopment

**Application Deadline:  
Varies**

In Connecticut, a brownfield is defined as “any abandoned or

underutilized site where redevelopment, reuse or expansion has not occurred due to the presence or potential presence of pollution in the buildings, soil or groundwater that requires investigation or remediation before or in conjunction with the redevelopment, reuse or expansion of the property.”



Such properties are common in Connecticut, due to our long-history and industrious roots. Brownfields are common contributors to blight, and it is important to take action to assess environmental conditions, identify pollutants, and establish a plan to remediate them so that these opportunity properties can return to productive re-use.

Federal, State, and local programs exist to incentivize redevelopment. [Let's talk](#) about options that may be available to address blight and pollution in your community.

## DEEP CERCLA 128(a) Brownfield Grant Program

Application Deadline: **November 22, 2024, noon**



The Connecticut Department of Energy and Environmental Protection (CT DEEP) is accepting applications for [Round 2 of the CERCLA 128\(a\) Brownfield Grant Program](#). Here is some key information:

- Municipalities and non-profit entities are eligible to apply;
- **\$750,000** is available for grants of **up to \$250,000 for Assessments** and **\$250,000 for clean-up**;

## Housing and Community Development-Related Funding Opportunities

### Homeland Security State and Local Cybersecurity Grant Program (SLCGP)

Application deadline: **December 3, 2024**



The Cybersecurity and Infrastructure Security Agency (CISA) and the Federal Emergency Management Agency (FEMA) are administering the [State and Local Cybersecurity Grant Program \(SLCGP\)](#). Nearly **\$280M** is available to support state, local, and territorial governments in reducing cyber risk and building resilience against evolving cybersecurity threats. Funding can be used to develop capabilities to detect, protect against, and respond to cyber threats.

## CTDECD Community Investment Fund

Application Deadline: **December 13, 2024**

The **Community Investment Fund (CIF)** has **\$175M** available for the fiscal year. Grants are available for: Capital improvement programs, such as brownfield remediation, affordable housing, infrastructure, clean energy development, and home or public facility rehabilitation; as well as planning for capital projects including activities such as community engagement processes, feasibility studies, development of project plan and construction budget.

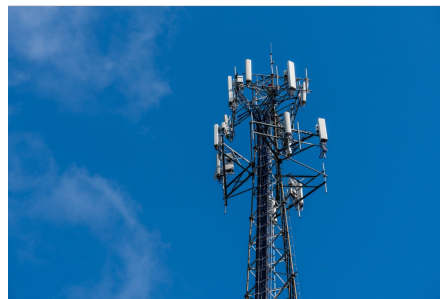

### **CT DEEP ConneCTed Communities Program**

Application Deadline: Rolling

Round two of the **ConneCTed Communities Grant Program** has **\$10M** available for the construction and deployment of broadband infrastructure designed to support the goal of universal access. DEEP is seeking applications for grant funding to facilitate low-income and multi-family curb-to-home and business broadband infrastructure buildout in underserved areas. All projects funded through this program must reach substantial completion before **December 31, 2026**.

### **CT DEEP BEAD Program**

Pre-Qualification Deadline (mandatory): **November 20, 2024**

Connecticut will receive \$144M to enhance broadband across the state, including through CT DEEP's

**Broadband Equity Access and Deployment (BEAD)** program. BEAD

is a competitive grant program that seeks to fund the deployment of broadband service to unserved and underserved locations. The grant has three phases: pre-qualification, scoring phase, and negotiation phase.

The **Connecticut Children's Healthy Homes Program**, developed with support from the U.S. Department of Housing and Urban Development (HUD) and the Connecticut Department of Housing, offers grants to improve the well-being of children. Funds can be used to **address the toxins and hazards often found in older or poorly maintained homes**. This program is eligible to **homeowners and tenants of all income levels**. 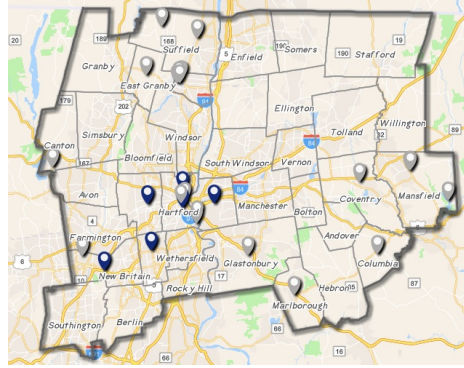

Additional funding has been awarded to non-municipal entities.

## A Reminder About ARPA Funds

Time is running out to obligate and spend ARPA funds. If you have unobligated funds, consider the expanded uses now available. This is further explained in the U.S. Department of Treasury Interim Final Rule of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF, a.k.a. ARPA Funds), which was published on September 20, 2023, and [CRCOG's Summary](#). The 2023 Interim Final Rule expands eligible uses of SLFRF to include:

1. Emergency relief from natural disasters;
2. Projects eligible under certain Surface Transportation Projects; and
3. Projects eligible under Title I of the Housing and Community Development Act of 1974.
