**1. Roll Call—0:00**—The meeting was called to order at 12:01 pm by Chair Jon Colman from the Town of Bloomfield. The Zoom attendance list will be used for roll call. Mr. Colman mentioned that CT-N is in attendance and the meeting will be broadcast.

**2. Public Forum—0:37**—There were no public comments.

**3. Adoption of Meeting Minutes from March 24, 2025—1:01**—A motion was made by Patrice Carson from the Town of Bolton, seconded by Eric Anderson from the Town of Andover, to adopt the minutes from the March 24, 2025, meeting. This motion was passed unanimously.

### **4. Staff Report**

- **60 Seconds for Safety—1:48**—Roger Krahn shared that two Crash Data Review meetings were held on April 15<sup>th</sup> and 16<sup>th</sup>. Meeting materials are available [HERE](#).
- **BIL/IIJA Update—3:18**—Elizabeth Sanderson provided updates on:

- **LOTICIP Quarterly Report—12:31**—Sotoria Montanari provided highlights of the LOTICIP Quarterly Report for Quarter 3 of FY2025.
- **Priority Pathways Public Meeting—15:28**—Mike Cipriano shared that there will be a virtual public meeting being held on April 29, 2025 from 6:30–7:30 pm for CRCOG’s Priority Pathways Study. Information can be found [HERE](#). He also mentioned that the study team will be attending various community events in May, June, and July.
- **Route 44 Corridor Study Draft Final Report—17:02**—Pramod Pandey shared that the DRAFT Final Report for CRCOG’s Route 44 Corridor Study in Canton is now available for public review and comment. Comments will be accepted through April 30, 2025. The report is available [HERE](#).
- **Connecticut 2055 Long-Range Transportation plan Public Meetings—19:17**—Cara Radzins shared that CTDOT is hosting two virtual public information meetings on April 24, 2025 at 12 pm and 6pm to provide an overview of the Connecticut 2055 Long Range Transportation Plan to gather feedback on the Plan’s draft goals. - **FHWA Series 500 Reporting—20:41**—Rob Aloise shared that the State sent a questionnaire to municipalities requesting information on transportation funding and projects. He noted that responses are due by May 1, 2025. There was discussion about the level of effort that this reporting would require of municipal staff. Mr. Aloise will follow up with CTDOT regarding Committee concerns and send out additional information.
- **CT Local Bridge Program—25:33**—Rob Aloise shared that the State Local Bridge Program is accepting applications through May 31, 2025. Federal Local Bridge Program applications are accepted on a continual basis. More information is available [HERE](#).
- **Draft Public Participation Plan—28:03**—Dagmar Noll shared that the Draft Public Participation Plan will be released on April 23, 2025. Virtual public meetings will be held on May 21, 2025 at 12pm and 6pm. Endorsement by Transportation Committee and

- **Executive Director Update—29:03**—Matt Hart congratulated Pramod Pandey and his team on the Route 44 Corridor Study in Canton on the release of the study’s Final Report. He shared information regarding the CRCOG Legislative Breakfast, which will be held on April 24, 2025 from 9am to 11am at the Legislative Office Building for the Policy Board members and their legislators. He also mentioned that CRCOG will be hosting a workshop on Transportation Insecurity in collaboration with UConn School of Public Policy. **5. TIP Amendments—32:06**—Rob Aloise reviewed the TIP Amendments. A motion was made by Patrice Carson from the Town of Bolton, seconded by Suzanne Choate from the Town of Windsor, to accept the TIP Amendments as presented. This motion was passed unanimously.

- District 1 – I-91/CT 190 -Replace Highway Signs and Supports
- Cromwell, Hartford, Rocky Hill, Wethersfield – I-91/CT 15 – Replace/Upgrade Cameras and Communication Equipment

**6. Resolution: FY2026 and FY2027 Unified Planning Work Program—34:24**—Cara Radzins shared that every two years CRCOG must prepare a Unified Planning Work Program that identifies activities associated with its transportation planning program. She sought endorsement of the draft UPWP, noting that the resolution empowered staff to make non-substantial edits to the document in response to CTDOT/Federal comments. A motion was made by Chris Edge from the Town of Berlin, seconded by Patrice Carson from the Town of Bolton, to approve CRCOG’s FY2026 and 2027 Transportation Planning Program. This motion was passed unanimously.

**7. Resolution: FY2026 and FY2027 CTDOT Planning Agreement—36.07**—Cara Radzins noted that funding for the activities outlined in the Unified Planning Work Program flows through CTDOT, and as such CRCOG needs to enter into an agreement with CTDOPT to access these funds. A motion was made by Chris Edge from the Town of Berlin, seconded by Patrice Carson from the Town of Bolton, the approve Execution of an Agreement with the Connecticut Department of Transportation for CRCOG’s FY2026 and FY2027 Transportation Planning Program. This motion was passed unanimously.

**8. Other Business—37:38**—There was no other business discussed.

**9. Adjourn—37:56**—The meeting was adjourned at 12:40pm. via motion by Patrice Carson from the Town of Bolton, seconded by Suzanne Choate from the Town of Windsor.
